INTERNAL BUSINESS USE GUIDANCE NOTES

1. INTRODUCTION

If you copy in copyright Land & Property Services (LPS)/ Ordnance Survey of Northern Ireland® (OSNI®) IP or material based upon in-copyright LPS/OSNI branded IP without LPS' permission you are acting in breach of the Copyright Designs and Patents Act 1988 (as amended) (the "Act") and infringing Crown Copyright.

2. COPYRIGHT IN LPS MATERIAL

Under the "Act", Crown Copyright subsists from the publication date to the end of that calendar year and then for a further 50 years. The Deputy Secretary of LPS has a delegation of authority from the Keeper of Public Records, in whom is vested by Royal Letters Patent the Crown Copyright in all Government information and works, for licensing the copyright and database right in all IP produced by LPS.

3. COPYRIGHT LICENCE

3.1 You need a copyright licence to make copies of LPS / OSNI branded IP for submission to:

The Planning Office. Land registration, Building Control, Court Proceedings or Property Vending. For the avoidance of doubt, permission to copy for property vending does not include advertising of property for sale.

All submissions must be on your business's behalf.

3.2 To reproduce LPS/ OSNI IP outside of your business for the purposes set out in clause 3.1, you will need either:

3.2.1 a Single Occasion Licence. This will allow you/ your business to reproduce LPS/ OSNI IP for applications one specified address; or

3.2.2 an Annual Copyright Licence. This licence is available by completing a Copying 1 application form. This licence is beneficial where you/ your business intend to reproduce more than 5 application in a 12-month period. It is non-refundable.

3.3 If your original IP has been downloaded from other Crown or licensed sources which allow downloads of LPS IP and contains third party Copyright please contact IPR Branch.

3.4 LPS complies with "Fair Dealing" as set out in the "Act". The Licence confers no right to obtain extracts of LPS' IP from public libraries. LPS IP obtained from public libraries may only be used for research or private study (for clarity, research is restricted to non-commercial purposes. Private study may not be for any commercial advantage).

5. RIGHT TO CANCEL

If you inform LPS in writing of your decision to cancel within seven (7) working days of the Commencement Date (for the avoidance of doubt the Commencement Date will be the date of issue of the Copyright Licence) we will not charge you.

6. TERMS OF PAYMENT

You shall without set off or deduction, pay to us all monies due in respect of the Copyright Licence in accordance with the Sales Policy (select this link to view the Sales Policy).

7. COPYRIGHT ACKNOWLEDGEMENT

Each authorised copy must include One of the following acknowledgements:
