Hi Cris,

I have attached the DfE Budget Settlement Letter which includes paras 4,5 & 6 in relation to **ring-fenced allocations**, which does not include the NDNA GEMS allocations, which are also ring-fenced. The Executive paper stated that these allocations would be allocated as part of the in-year monitoring process and are not included in the DfE 2021/22 opening budget allocation.

This does not include the £0.264m RDEL for GEMS.
