Under the Freedom of Information Act, I would like to request details regarding press and communications staff working on behalf of the department.

I am seeking an update on a similar FOI request submitted last year.

Please disclose the following, both in terms of head count and full-time equivalent:

1. The number of press and communications staff.
2. A breakdown of these staff by job title (e.g. number of press officers, heads of press office, directors of communications, social media staff, etc).
3. The overall spend on salaries for these staff in the year 2025/26.

DoF response

I can confirm the Department holds the information requested. Please see responses to the questions below.

1. The number of press and communications staff.

The Department of Finance (DoF) has press and communications staff who work on behalf of the Department including Land & Property Services (LPS) and NISRA.

DoF also has staff who work on behalf of the Northern Ireland Civil Service (NICS) across all departments. In the interests of transparency details have been included for both – see point 2.

2. A breakdown of these staff by job title

Where a job title isn't provided the equivalent grade has been listed.

DoF staff working on behalf of NICS

NICS wide services include nidirect, the Government Advertising Unit (GAU), Integr8 and People and Organisational Development.

nidirect is the official government website for citizens providing a service on behalf of all Northern Ireland departments and other public bodies.

GAU procures and manages both classified and campaign advertising on behalf of all Northern Ireland departments and other public bodies.

The Integr8 programme will transform how finance and HR services are delivered within the NICS.

Spend on salaries for staff in DoF working in external and internal communications on behalf of the Department was £827k.
