The group was formed in 2019 in preparation for the Civil Service's submission to the 2020 Stonewall Workplace Equality Index. The role of the Steering Group is to ensure that activity is coordinated across departments, that good practice is shared and to strategically manage the overall submission process.

They are one of a number of internal stakeholders that we engage with when developing or reviewing HR policies. The purpose of liaising with this group is to ensure we make our policies and practices are LGBT inclusive and comply with Section 75 obligations.
