I will send an invite shortly for a meeting tomorrow at 12:30pm as I know you are keen to have this matter resolved quickly. I promised I would provide you with an indication of where the panel felt that the proposal to trawl fell short and I apologise that I wasn't able to do so earlier in the day.

The overriding impression was that the eligibility criteria were too weak to support a trawl. In all of the criteria listed we felt phrases like "contributing to" and an "awareness of" weakened the case. I know that mentally Stephen and yourself might have a very clear idea of what you would see as the type of experience or evidence that would see an applicant successfully passing through sift but for us looking as the criteria as listed it is difficult to see how any serving SO might not make a case that they meet the criteria listed. That being the case we would ask why not take from the external DP competition? There is a process whereby NICSHR corporate competitions work with business partners to try to find the best match for the vacant post and project experience was one of the areas where applicants were asked to list their experience.

I know you will have considered that option and still have opted for the trawl, at this stage it is a matter of strengthening the case, hence our offer to meet with you. Below I have shown the eligibility criteria for an LPS vacancy IRC258612 which was approved for trawl next to yours. I promise you I didn't cherry pick this, it was the first CIB I came across based on a word search in Content Manager, I'm not saying that this is in any way typical, I provide it only as an example. The main difference and probably the reason it was accepted as a trawl is the qualification.

There is a fine line between tightening the eligibility criteria and reducing the potential pool of applicants to the point where there is little opportunity of filling the post. This is essentially the nature of trawls, the requirement should be such that only a small minority of the feeder grade(s) can meet it, if that isn't the case take from the appropriate promotion list.
