## DoF Response

I can confirm the department holds some of the information requested.

1. There is no anticipated date for when the NICS will be making offers of appointment from competition IRC277837.
2. As at the end of April 2023 (the most recent figures available), of the vacancies not to be filled from IRC277837, there are a number being filled from categories deemed as a priority by NICS. The remainder have additional specialist requirements which means that they are not suitable to be filled from competition IRC277837.
