#### 1.0 INTRODUCTION

Construction and Procurement Delivery (CPD) is a Centre of Procurement Expertise (CoPE). It is responsible for disseminating advice and guidance on the direction and policies on public procurement to the Northern Ireland public sector and monitoring their implementation. It is also responsible for managing procurements on behalf of central government departments, their agencies and arm's length bodies.

In order to establish tender competitions in respect of electricity and gas and to manage the resultant contracts CPD requires energy market intelligence and expertise to provide specialist electricity and gas advisory services to the following bodies:

- Construction and Procurement Division (CPD)
- Education Authority (EA)
- Translink
- Business Services Organisation (BSO)
- NI Water (NIW)

The contracts awarded by these bodies are summarised in the table below and set out in more detail in sections 2 to 4:

All in scope energy contracts will be subject to regulated charges set by the Northern Ireland Authority for Utility Regulation.

The Contract will commence on the Commencement Date for two years with two extension options of 12 months each.

#### 2.0 CONSTRUCTION & PROCUREMENT DELIVERY (CPD)

CPD, Supplies and Services Division has previously put in place collaborative arrangements in respect of metered and unmetered electricity, and natural gas.

#### 2.1 SUPPLY OF METERED ELECTRICITY

#### **Current Arrangements**

The current collaborative contract for the supply of <u>metered electricity</u> to public sector buildings in Northern Ireland commenced on 1 April 2020. The contract will expire on 31 March 2022.

#### Future Requirements - Metered Electricity

It is anticipated that at this time CPD will establish a new contract for the supply of metered electricity to the highest rank tenderer. The Energy Market Advisor will be required to provide expertise to assist in the tendering of this requirement.

It is anticipated this requirement will be required every two years.

#### Future Requirements - Unmetered Electricity

It is anticipated this requirement will be required every two years.

#### 2.3 SUPPLY OF NATURAL GAS

#### **Current Arrangements**

The current collaborative contract for the supply of natural gas to public sector buildings in Northern Ireland commenced on 1 April 2021. The contract will expire on 31 March 2023.

#### Future Requirements - Natural Gas

CPD will commence work to undertake a tender competition to establish a new Collaborative Contract. The new Collaborative Contract will commence on 1 April 2023.

It is anticipated that at this time CPD will establish a new contract for the supply of natural gas to the highest rank tenderer. The Energy Market Advisor will be required to provide expertise to assist in the tendering of this requirement.

It is anticipated this requirement will be required every two years.

#### 3.0 BUSINESS SERVICES ORGANISATION (BSO)

The Business Services Organisation (BSO) provides a broad range of regional business support functions and specialist professional services to the health and social care sector in Northern Ireland. BSO is also a Centre of Procurement Expertise (CoPE).

#### 3.1 SUPPLY OF METERED ELECTRICITY AND GAS

#### Future Requirements - Metered Electricity

NIW will establish a new metered electricity contract. The new contract will commence on 1 October 2021.

It is anticipated this requirement will be required every two years.

#### 5.0 ENERGY MARKET ADVISORY SERVICES - REQUIREMENTS

In order to establish tender competitions in respect of electricity and gas and to manage the resultant contracts CPD requires energy market intelligence expertise to provide specialist electricity and gas advisory services to a variety of bodies across the Northern Ireland Public Sector.

#### 5.1 Services A: Advisory Services to support Tender Exercises

- Assisting with the development of specifications and Client specific pricing models for tendering
- (ii) Obtaining from suppliers appropriate consumption data, verifying supply points with users and presenting in a pricing schedule for tendering

- (iii) Analysing and manipulating half hourly and non-half hourly data into the DUoS and TUoS time bands to ensure accurate application of pass through charges including DLAF
- (iv) Assisting in the development of tender assessment methodologies
- (v) Implementing pricing models for fixed price or risk managed\* Electricity/Gas Contracts
- (vi) Assisting in responding to clarification queries during tender exercises
- (vii) Input into client handover documentation including final competition rates
- (viii) Assisting in the verification of tender compliance
- (ix) Assisting in assessment of tenders
- (x) Evaluate the pricing schedule

#### 5.2 Services B: Contract Services

- (i) If required, providing a detailed handover report (including sample billing layout) to all clients advising of indicative future costs based on historical consumption and the winning tenderers supplier margin
- (ii) Completing network transfer forms as required
- (iii) Maintain a central register of all meter points (inclusive of additions and removals during the contract period)
- (iv) Obtaining savings reports as required
- (v) Liaising with SIB for consumption data transfer into SIB's central database
- (vi) Assisting clients with managing their energy contracts

#### 5.3 Services C: Ad Hoc Advisory Services

<sup>\*</sup> The risk managed service is provided by a separate contract and not a requirement for this contract.

Some ad hoc Energy Advisory Services may be required during the life of the Electricity and gas contracts and may include advice regarding;

- Market trends including energy price fluctuations
- Tariffs
- Post purchase analysis
- Regulatory changes
- Market review and associated services including update on suppliers and emerging markets

This ad hoc advice may be required in writing, by attending meetings and/or undertaking presentations.

#### 5.4 Services D: Knowledge Transfer Services

Knowledge transfer may be required by providing up to 2 days training per year to each participating body.

#### 5.5 Services which are Out of Scope

The following services are currently provided via a separate contract (ID 2621210) and will remain out of scope from this contract while contract ID 2621210 is in place, but may be provided through Services C of this contract if contract ID 2621210 is not replaced.

#### **Strategy Development**

- Development, implementation and achievement of existing and future business plans and procurement strategies for energy procurement
- Preparation of savings strategies
- Review of existing energy procurement processes and procedures
- Recommendations on hedging strategies and term
- Post purchase analysis and counter-factual comparisons

- Identifying and analysing potential market changes that may impact costs (regulatory, new market entrants, changes to pass through, wholesale etc.)
- Carrying out risk analysis on each portfolio of contracts

- Post hedge reports by client and by sector

#### **6.0 KEY PERSONNEL**

During the contract period the contractor must provide Key Personnel. Key Personnel are deemed to be

- a. The Energy Advisor: whose role is to ensure the delivery of all technical services required by the Contract
- b. The Key Account Manager: whose role is ongoing customer support and delivery of all services required by the Contract, the smooth running of the Contract and attendance at any Contract review or other meetings required

The Key Personnel must have the skills and experience to undertake their roles. The roles may be undertaken by the same person.

The Key Personnel must have at least two years' experience gained within the last five years within the energy industry of delivering services as an Energy Advisor or Key Account manager.

The Contractor must provide names and contact details of the individuals who will perform these roles.

#### 7.0 KEY PERFORMANCE INDICATORS

The Contractor's performance will be measured against the following key performance indicators (KPIs):

- Acknowledgement and resolution to queries within 2 working days
- Acknowledgement and resolution to tender clarification queries within 2 working days
- Complete evaluation of pricing schedule within 3 working days (assuming no queries or anomalies)

- Complete network transfer forms and provide confirmation to client that form issued to supplier within 3 working days

The Contractor must put in place mechanisms to measure its performance against these KPIs and report on these KPIs at Contract review meetings.

The Contractor will be required to be complete a monthly spend return to CPD.
